TREATMENTS START AT \$10.00 per day.

Veterinary, Dental & Farrier Services will be provided for admitted horses and/or foal as needed; at the owners' expense. Board includes hay, pasture & Buckeye ration balancer. Any additional nutritional requirements i.e. additional caloric intake for foals, broodmares, senior/geriatric horses, debilitated or malnourished horses, hay cubes, metabolic feed for PPID or EMS horses will be an additional charge.

A fecal exam will be performed on all horses admitted to KVC. If the horse has intestinal parasites it will be treated for those parasites. The owner agrees to pay for the fecal test & any necessary treatment.

**All fees, including Board, Farrier and Veterinarian, must be paid-in-full BEFORE departure. We require twenty four hours notice prior to picking up your horse. PAYMENT IS DUE IN FULL ON THE ACCOUNT BY THE 15<sup>TH</sup> OF EVERY MONTH.**  
*Horses are not monitored/watched 24 hours a day.*

Any unpaid expenses, board or fees requiring collection will incur the legal rate of interest plus attorney's fees.

Any disputes of a legal matter must be settled in Kent County, Maryland.
